On the 13 May 2005, 1st. Pl. B Co. ATRASH A33 has SSG [REDACTED] Bradley Commander, SGT [REDACTED] Gunner, PFC [REDACTED] Driver, A34 myself SFC [REDACTED] Bradley Commander, PLT SGT, SGT [REDACTED] Gunner, SPC [REDACTED] Driver. Were asked to drive LT [REDACTED] and LT [REDACTED] to FSN [REDACTED]. In the back of A34 was Sgt [REDACTED], SPC [REDACTED], and Pvt [REDACTED]. In the back of A33 was LT [REDACTED] and LT [REDACTED]. The point to FSN left at 2200. The route we took was route [REDACTED] to [REDACTED]. A33 was hit by an IED on route [REDACTED] at 2250 at [REDACTED]. The A33 truck pushed through the kill zone and called me on the radio to inform me that the truck and crew was not injured. I called the A to talk to inform them about the IED attack. At the same time A33 did a deliberate scan of the area facing towards the west. I did not see with my truck to the east. Both looking for the trigger man. A33 called me on the radio informing me there was a man towards the west lying in the ditch with a wheel and acting very suspicious. I called [REDACTED] to inform them. [REDACTED] was on the radio He said to use the ROE. I called to the A33 truck to see what the man was doing. A33 said he was trying to get away. So I told the crew to fire warning shots. We were advised by [REDACTED] there were no friendly in the area. So A33 fired warning shots with 7.62 mm. Both A33 and my crew A34 Accessed the Area for possible collateral damage of buildings in the kill zone, or personnel outside because it was 2253 well past curfew. The warning shots did not stop the man from running, so A33 used the escalation of force. The A33 Gunner shot a V-12 round burst of ones 7.62 mm dead center of the man killing him. A33 SSG then observed the man fall to his death. I gave the A33 the cease fire. Then A33 SC called my truck A34 said the target was down. A33 pulled for security while my truck went to objective. The dead trigger man had an about 100 more meters from the road making it 500 meters from the IED explosion. After finding the dead man, I had the dismounts search the body and the Area for the triggering device but none was to be found. I called [REDACTED] for further guidance, and was told to wait for [REDACTED] to show up on site. They showed up on site at 2300 and took the dead body to [REDACTED].

There were no personnel or vehicle damage. We then started scanning the area for a possible trigger man. My gunner identified a man laying in a field about 250 meters from where the IED went off. We observed him pick up a shovel and start to run away. My gunner shot several warning shots with coax 762. The man continued to run so using escalation of force my gunner started firing killing burst of coax 762. On 15 May 2005 my brother Section A33 and A34 we a task to go to Myanmar. A33 contained SFC [REDACTED], SGT [REDACTED], PFC [REDACTED], IL [REDACTED], and IL [REDACTED]. A34 contained SFC [REDACTED], SGT [REDACTED], SFC [REDACTED], SGT [REDACTED], SGT [REDACTED], SFC [REDACTED], and PFC [REDACTED]. While traveling along route Horthy approximately 0250 A33 was struck by an IED in grid [REDACTED]. We pushed through the kill zone and started assessing vehicle and personnel injuries. There were no personnel or vehicle damage. We then started scanning the area for a possible trigger man. My gunner identified a man lying in a field about 250 meters from the IED site. We observed him pick up a shovel and start to run away. My gunner shot three 203 rounds wounding shots with COMBAT 7.62. The man continued to run so using escalation of force, my gunner fired four 6 to 9 round killing burst of COMBAT 7.62. After seeing the target fall I told my gunner to cease fire. There were no buildings or houses within 300 meters of the target. Finally A34 moved through the field to assess the casualty. End of statement the witness follows:
